

Release of Liability for High Risk Activity

1. I understand that my child may engage in certain "high risk" activities while at Big Sky Build It!, operated by Big Sky Learning, LLC ("Activities"). I also understand that my child may create certain devices capable of causing bodily injury and/or damage to property. The types of devices will vary depending upon the camp(s) I choose for my child to attend. I also understand that my child will take these devices from the camp(s), beyond the supervision and guidance of Big Sky Build It! staff, and that I am responsible for ensuring safe use of the device(s).

2. I acknowledge that participating in the Activities involves certain risks (some of which I may not fully appreciate) and that injuries, death, property damage or other harm could occur to my child, myself, or others. I accept and voluntarily assume all risks of any injuries, damages, or harm which may occur during, or result from, my child's presence during or participation in the Activities, regardless of whether or not caused by the negligence or other fault of Big Sky Learning, LLC or its affiliates or their respective contractors, interns, volunteers, employees, officers, agents or insurers ("Released Parties"), in whole or part.

3. On behalf of myself and my child, I waive all claims against any of the Released Parties for any injuries, damages, losses or claims, whether known and unknown, which may occur during, or result from, my or my child's presence during or participation in the Activities ("Claims"), regardless of whether or not caused by the negligence or other fault of any of the Released Parties, in whole or part. On behalf of myself and my child, I release and forever discharge the Released Parties from all such Claims.

4. I agree to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including without limitation reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I or my child (or anyone claiming by, under or through me or my child) may bring against any of the Released Parties related to injuries or damages that may occur during, or result from, my or my child's presence during or participation in any of the Activities, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties. I also agree to indemnify and hold the Released Parties harmless from all claims, losses, liabilities, damages, costs or expenses (including without limitation reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I or my child (or anyone claiming by, under or through me or my child) or any third party may bring against any of the Released Parties for injuries or damages caused by, or related to, the device(s) created by my child, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties.

5. I have carefully read and reviewed this Waiver, Release And Hold Harmless Agreement. I understand it fully and I execute it voluntarily.
